STIPULATED CONSENT JUDGEMENT

As attested to by the signatures of the parties below, this matter comes before the Court and the parties' joint stipulation.

Plaintiff QOTD Film Investment LTD, has filed a complaint against the defendant in the Southern District Court of California for copyright infringement, 17 U.S.C. §§101, et seq, for the unlicensed copying, promotion and distribution of plaintiff's motion picture titled *Queen of the Desert*, registered with the United States Copyright Office, Registration No. PAu 3-766-976, 2015.

The defendant, initially identified as Doe-68.8.59.127, has confirmed Meagan Reames as the IP address user, who lived at the time of the infringement at 109 Bloom St. Oceanside, CA 92058. The parties, after conferral and investigation, now appear to fully and finally resolve all

claims between the parties and the matters before the Court and have moved for entry of this Stipulated Consent Judgement to effect the terms of their settlement.

Identity of the Defendant

The defendant identified as a user herein of IP address 68.8.59.127, has been confirmed to be Meagan Reames who resided at 109 Bloom St. Oceanside, CA 92058, during the time of infringement.

WHEREFORE IT IS HEREBY STIPULATED AND ORDERED for all matters relevant to this case between the parties as follows:

1. This court has jurisdiction over the parties and venue is proper.
2. Plaintiff QOTD Film Investment LTD, has valid and enforceable copyrights in the original copyrighted work, *Queen of the Desert*, (“motion picture”) registered with the United States Copyright Office, Registration No. PAu 3-766-976, 2015.
3. Meagan Reames is the proper named defendant in this case and liable under plaintiff’s claims.
4. Defendant was specifically advised to have this matter reviewed by independent counsel and referred to the California State Bar Lawyer referral Service:

5. Plaintiff and defendant Meagan Reames expressly consent to have a United States Magistrate Judge conduct any and all proceedings in this case, including entry of orders, this stipulation or any other final judgement or orders arising therefrom.
6. Meagan Reames has fully reviewed the Complaint and the allegations of the Complaint and specifically admits plaintiff’s investigations identifying the IP address to be accurate,

in particularly in accurately identifying the IP address as the IP address used to download and distribute plaintiff's motion picture and other content identified with the Complaint.

7. In addition to other terms in a separate settlement agreement, the parties further agree and require pursuant to the settlement the below Permanent Injunction be entered against Meagan Reames.

Money Judgment

Money Judgment is awarded in favor of plaintiff and against Meagan Reames in the amount of \$10,500.00 for damages, costs and fees in this matter.

PERMANENT INJUNCTION



Meagan Reames is hereby directed to immediately delete all unlicensed content of *Queen of the Desert* and cease all unlawful use of this motion picture on any computer(s) she owns or controls.
